





















PRIVACY NOTICE FOR SUPPLIERS/FREELANCERS

Dear Suppliers, we would like to inform you that the *European Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data* ("GDPR" from now on) provides for the protection of persons and other subjects regarding the processing of personal data. **GEROSA GROUP**, pursuant to Articles 13 and 14 of the GDPR, therefore, provides you with the following information:

	<p>C. SOURCE OF PERSONAL DATA: personal data are collected directly from the data subject and, only possibly, they can come from public registers.</p>
	<p>D. PURPOSE OF DATA PROCESSING AND LEGAL BASIS: personal data are processed by the Data Controller for the following purposes:</p> <ul style="list-style-type: none"> • Purposes related to legal obligations: such as accounting, remuneration, social security, welfare, insurance, tax, anti-money laundering, anti-mafia or obligations provided for by law, regulations and community legislation, ... • Purposes related to the management of pre-contractual measures and for the fulfillment of the contract: to fulfill the contractual obligations between the parties; to exercise or defend a right in court; for all purposes related to the management of relationships deriving from the role you have held, management of relationships with customers and suppliers and possibly to register your presence within the offices of the owner. • Purposes related to the existence of a legitimate interest on the part of the Data Controller: <ol style="list-style-type: none"> 1. Video surveillance. Some rooms of the structure are subject to video surveillance for reasons of security and protection of the company's assets and are marked by special signs with the stylized image of a camera; 2. Processing of employee or similar data of suppliers for the management of relations between the parties (owner-supplier).

DATA RECIPIENTS: within the limits relevant to the purposes, your data may be communicated to various recipients such as public and private bodies by law or communicated to subjects functional to the achievement of the purposes set out above internal and external to the Data Controller such as, but not limited to, collaborators, freelancers, insurance companies, insurance intermediaries, law firms, technical partners, banking institutions, transport companies</p>
	<p>F. TRANSFER OF DATA TO THIRD COUNTRIES: the data collected are not subject to transfer to third countries outside the European Economic Space</p>
	<p>G. RETENTION PERIOD: the data collected will be kept for a period of time not exceeding the achievement of the purposes for which they are processed ("principle of storage limitation", art.5, GDPR) or according to the deadlines provided for by law. The verification of the obsolescence of the data stored in relation to the purposes for which they were collected is carried out periodically.</p>
	<p>H. RIGHTS OF THE DATA SUBJECT: each data subject is always entitled to request the Data Controller to access, correct or delete his data, limit the processing or objecting to the processing, requesting data portability, revoking consent to the processing of data, claiming these and other rights provided by the GDPR through a direct communication to the Controller. The data subject can also lodge a complaint with a supervisory authority.</p>
	<p>I. OBLIGATION OF THE DATA SUBJECT TO PROVIDE PERSONAL DATA: the provision of your data is strictly necessary for the performance of the aforementioned activities by the organization for the purpose of establishing / executing and correctly managing the relationship and is also mandatory for the fulfillment of legal obligations. Therefore, failure to provide data will make it impossible for the organization to perform the aforementioned activities / to establish and execute the relationship.</p>
	<p>J. METHODS OF DATA PROCESSING: the personal data you provide will be subject to processing operations in compliance with the aforementioned legislation and the confidentiality obligations that inspire the activity of the Data Controller. The data will be processed both with IT tools and on paper and on any other type of suitable support (eg cloud systems, digital replacement storage and preservation systems, ...), in compliance with adequate technical and organizational security measures provided for by the GDPR.</p>
